Session Descriptions

"Becoming a Home Care Hero: The Four Processes of Motivational Interviewing"

The conversations that occur between helping professionals and their clients are powerful ones, capable of supporting or inhibiting the innate change process that is alive in all of us. Learn to make your interactions with clients more satisfying and effective using The Four Fundamental Processes of Motivational Interviewing (MI): Engaging, Focusing, Evoking, and Planning. Dana will explore each of these four processes in depth, and you'll leave with at least three new ideas to incorporate into your practice.

Objectives:

- Describe the four processes of Motivational Interviewing (MI): Engaging, Focusing, Evoking, and Planning
- Ask change talk focused questions to elicit intrinsic motivation for change

"Value Based Purchasing: Functional Scores and Best Practices"

Outline the 5-year HHVBP demonstration and impact on 9 participating states. This session will detail the changes to the HHVBP in the last 2 years of the demonstration. In addition, we will analyze how the HHVBP model affected outcomes for everyone.

- Review the structure to the HHVBP that ended in 2020
- Review the changes to the measures included in HHVBP
- Detail the functional M1800 items included in the Composite Mobility Measures
- Evaluate the best clinical practices for getting the best outcomes.
- Review what agencies should do to prepare for nationwide rollout

"Oregon Health Authority State Hospice Update"

In this session, OHA will provide a hospice update including the new hospice rulemaking and palliative care rules.

"Value Based Purchasing: HHCAHP Survey and Best Practices"

This session will review the exact groupings and specific questions from the HHCAHP survey that will impact the nationwide rollout of VBP. This session will also look at the calculation of Achievement & Improvement scores utilized in VBP calculations and how they apply to HHCAHP scores.

"Finding and Keeping Home Care Heroes: Why Workforce Matters"

This presentation is based on the premise that a competent, well-trained staff is key to successful operations and quality outcomes for home health and home care agencies in Oregon and across the country. Dr. Stone will provide an overview of the state and national home health/home care landscape, highlighting current and future projections of agency growth and the demand for and supply of staff, particularly nurses and home care aides. This will be followed by a discussion of the key policy and workforce development challenges to this growing care sector, including the lack of quality education and training and barriers to recruitment and retention of staff at all levels. The presentation concludes with examples of best practices—both evidence-based and promising—that can help agencies address the challenges and take advantage of the opportunities for growth and success.
