Highlighted Accomplishments

- Transitioned all OAHC association management activities and lobbying to Legislative Advocates and retained Fawn Barrie as the new Executive Director
- Continued consistency for members by maintaining Brandy Sweet as Memberhip Services Coordinator
- Established an In-Home Care committee to advise the Board specifically on In-Home Care issues
- Lobbying Congress: face-to-face, nurse practitioners ordering, prior authorization/pre-claim review, value based purchasing
- Support of Congressman Walden: Walden has been working closely with OAHC in his effort to introduce legislation on face-to-face. Coordinated with staff, met with other congressional offices, drafted press strategy

- Continued advocacy and coordination with stakeholders on physician orders for patients across State lines via reciprocal agreements with neighboring States
