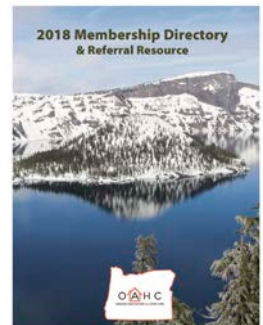

Listserv & Blog

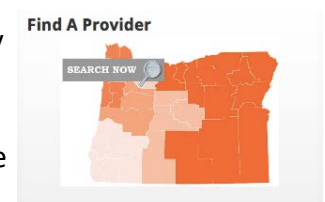

The Oregon Association for Home Care developed the online Home Health & Hospice Aide Competency exam and study guide as a standard for our industry. This examination tests the basic competencies of individuals who have received training in accordance with the Oregon Nurse Practice Act, to work as nursing assistants.

The study guide is for the OAHC Home Health & Hospice Aide Exam. This study guide was developed to assist the Certified Nurse Assistant hired for the position of Home Health Aide to better familiarize themselves with the areas of care in which they may be responsible. The study guide was developed based on various contributions from individuals serving on the OAHC Education and Conference Committee.
